A Big Increase in IRS Fees

On January 3, 2006, IRS released Revenue Procedure 2006-8 which is the pronouncement that comes out the first week of each year providing the new user fee schedules for requesting Private Letter Rulings (PLRs) and other requests for IRA and plan related issues. But this year contained a shocking surprise. The fees were increased exponentially, especially for a typical IRA related PLR. The average IRS fee now (for rulings requested from February 1, 2006 and later) jumps from \$625 to \$9,000!
