2005 was a big year for IRA related rulings including two new tax laws (The Bankruptcy Act and the Katrina Act) that featured numerous IRA provisions. a Supreme Court Ruling (also dealing with bankruptcy and IRAs), an IRS Revenue Ruling (Revenue Ruling 2005-36), and what seems now to be a regular weekly flow of Private Letter Rulings (PLRs) that you need to know about so that you know how IRS might rule if you have similar

issues.

Once again, many of the PLRs dealt with the 60-day rollover provisions in cases where people withdrew money from their IRAs and did not return the money to an IRA or plan within the required 60 days and sought relief from IRS. Although many of the rulings were favorable, allowing the tax-payers more time to complete the botched rollover, there were also several ruling requests denied by IRS where the taxpayers either used the money while it was outside of the IRA or where they

could not prove they truly intended to do a rollover. That is a key test. In several rulings IRS allowed executors to complete rollovers after the death of the IRA owner.
